PROJECT DESCRIPTION

Pediatric Health Network is partnering with Children's National Hospital's premier Asthma Program, IMPACT DC, to launch our network-wide virtual asthma quality program, Advancing Asthma Care: A PHN Initiative. PHN will help practices leverage their own data to drive improved health outcomes for their asthma population, while increasing value and patient and practice team satisfaction. We are asking practices to select a data champion who will pull data on quality measures and who will meet with their practice team to review and act on the data to improve care. Working together with your practice champions, PHN will share best practices and provide guidance on extracting actionable data from your EMR.

INITIATIVE GOALS & OBJECTIVES

We aim to identify and optimally manage your population of patients with persistent asthma. Project objectives:

1. Identify patients with asthma and stratify the population to identify those patients who may need more help managing their condition
2. Develop targeted education and interventions to help all patients achieve better health outcomes
3. Measure the impact of interventions using quality improvement methodology
4. Achieve improvement on asthma control measures

PROJECT SCOPE

Practice Education:

- Bi-Monthly Educational Webinars
 - o Didactic presentation
 - o Sharing best practices and practice data
 - o Review of asthma toolbox materials
- CME, MOC Part 2 and MOC Part 4 credit will be available

Data Driven Improvements:

- Bi-Monthly data champion meetings
- Stepwise approach to extracting and analyzing practice data
- Practices choose metrics, review data and develop improvement plan

ADVANCING ASTHMA CARE: INITIATIVE OUTLINE

PHASE 1

Objective:

Identify your practice's current population of asthma patients and, within that population, those with persistent asthma

Actions:

1. Each practice or practice group will identify a practice data champion
2. Data champions will pull practice data and will meet virtually with PHN QI team and other practices to review and discuss data
3. Each practice or practice group will select project asthma measures they'd like to improve

PHN Support and Shared Resources:

1. Coaching cohorts of practices as needed
2. Data super users share best practices

PHASE 2

Objectives:

- Incorporate the environmental and social factors that impact asthma health outcomes and health equity
- Identify patients who would benefit from care management

Actions:

1. Develop a practice-specific approach to documenting environmental and social factors
2. Use race and zip code to examine your population's asthma health outcomes
3. Implement a practice care management plan

PHN Support and Shared Resources:

1. Tips to create and capture structured data from your EMR
2. Care Management support and care plan template design

PHASE 3

Objective:

Demonstrate asthma control using selected measures

Actions:

1. Collect and submit data on selected asthma measures
2. Use quality improvement methodology to demonstrate improvement of asthma control

PHN Support and Shared Resources:

1. Coaching cohorts of practices as needed
2. Quality improvement support
3. Project data assimilation and reports

MENU OF ASTHMA MEASURES

Practices are asked to select at least 2 of the 6 measures outlined below. If providers in your practice are participating for MOC Part 4 credit or if your practice is participating in PHN's Aetna contract, there are specific measures your practice must select at a minimum.

1. Consistent use of Asthma Control Test (ACT) to measure control (**required for MOC**)
2. Conduct PCP Asthma check-in visit at least every 4 months for patients with persistent asthma
3. Develop method to track ED/hospitalizations
4. Develop method to track persistent asthma population
5. Integrate care management referral process into office workflow
6. Patients in care management achieve goals in care plan

PRACTICE PARTICIPATION REQUIREMENTS

Practice Responsibilities

- a. Identify a practice data champion and complete survey providing data champion's contact information: <https://www.surveymonkey.com/r/BDPWQPR>
- b. Choose measures you want to improve from the menu provided
- c. Meet regularly (ex: every other month) to review data pulled by data champion and plan improvement

Data Champion Responsibilities

- a. Attend live or review recording of at least 75% of the data champion meetings
- b. Submit all requested data elements
- c. Review data with practice team
- d. Create a practice account on Glasscubes to access all project resources

Clinician Responsibilities

- a. Attend live or review recording of at least 75% of the educational sessions
- b. *Optional*: complete MOC Part 2 and/or Part 4 requirements

MOC PART 2 REQUIREMENTS

MOC Part 2 Credits will be awarded through Inova ICMES system. To gain MOC Part 2 credits:

- Complete pre-test for the educational session on the Inova ICMES site
- Attend the educational session live or watch the recording on the Inova ICMES site
- Complete post-test for the educational session on the Inova ICMES site
