

Pandemic Adolescent Health: Teens & COVID-19

Youth have a critical role in the spread and transmission of COVID-19

- Based on national data reported to the CDC, from March-Dec 2020:
 - 18-24yo had the highest # weekly new cases of any age group
 - o 14-17yo had the third highest weekly incidence



FUTURE OF PEDIATRICS

- National text survey of 797 youth 14-24yo conducted in October 2020
- Reasons why preventing spread to others (21.1%), other's behaviors (15.7%) and protecting oneself (15.3%)
- Much situational variation in how youth defined safe settings and close contacts



Pandemic Adolescent Health: Youth Behaviors

- Youth continue to see friends and romantic/sexual partners
- Romantic and sexual interactions also happen virtually

• Reported use of tobacco, cannabis, alcohol did not change after the stay-at-home order period

Pandemic Adolescent Health: General Health Services

The pandemic has impacted and transformed health services for youth in a variety of ways.

- Interruption of preventative health services including vaccinations
- Telehealth and virtual communication have assumed more priority due to physical distancing constraints impacting care
- Traditional barriers to care for teenagers are now augmented by new access barriers
- Delayed or deferred care results in higher acuity at presentation

Pandemic Adolescent Health: SRH Services

 Sexual and Reproductive health has been specifically challenged by access barriers to confidential care, testing and treatment supply shortages


- Online survey of 2005 youth 16-24yo in the UK
- Factors impacting access to contraceptive services:
 - Restriction of SRH services, lack of knowledge about how to access
 - Closure of usual points of access for free condoms or services
- ²⁰ Reluctance to access services during lockdown
 - Unable to access supplies/services due to independence, embarrassment or confidentiality constraints

- Other key findings:
 - Confusing messages about contraception causing distress/anxiety
 - Limited STI testing contradicts messaging about routine/asymptomatic testing
 - Changes in sexual behavior more unprotected sex, avoiding sex, stopping contraceptive method

- National testing data 1/19-6/20
- CT/NG testing decreased by 59% for females (A) and 63% for males (B)
- Testing nadir in April 2020 accompanied by increase in CT/NG Positivity rates

Pandemic Adolescent Health: SRH Strategies

- Optimize preventive health opportunities
- Cultivate health literacy, including minors' rights to confidential SRH care, how to access health information and health services
- Re-evaluate minors' access to confidential SRH services in the context of pandemic changes to operations
- Get smart on social media and other youth-friendly virtual tools for health promotion, health education, and service delivery
- Leverage telehealth to expand access to SRH services

Telehealth: Contraception

Some concerns can be initially or entirely managed via telehealth

- Contraception counseling
- Pregnancy concern and options counseling

Many forms of contraception can be prescribed by telehealth

- Provider comfort level with contraceptive management and familiarity with patient are key factors
- A pregnancy test is not strictly needed to assess for pregnancy prior to starting contraception

Telehealth: Contraception without a Pregnancy Test?

How To Be Reasonably Certain that a Woman Is Not Pregnant

In most cases, a detailed history provides the most accurate assessment of pregnancy risk in a woman who is about to start using a contraceptive method. Several criteria for assessing pregnancy risk are listed in the recommendation that follows. These criteria are highly accurate (i.e., a negative predictive value of 99%–100%) in ruling out pregnancy among women who are not pregnant (*16–19*). Therefore, CDC recommends that health care providers use these criteria to assess pregnancy status in a woman who is about to start using contraceptives (Box 2). If a woman meets one of these criteria (and therefore the health care provider can be reasonably certain that she is not pregnant), a urine pregnancy

CDC's "Selected Practice Recommendations for Contraceptive Use" offers guidance on assessing pregnancy risk by history alone (LMP and date of last sexual encounter).

Telehealth: STI Management

Most concerns can be initially or entirely managed via telehealth

- Detailed risk assessment, counseling and empiric treatment
- Need for in-person care can be determined on an individual basis
- Syndromic management can additionally limit in-person care; close follow up is prudent
- In-person care is indicated when sensitive physical exam or medical procedures are critical for management



Pandemic Adolescent Health: LGBTQ Youth

LGTBQ youth experienced an increase in disparity of negative mental health outcomes

• Social distancing may lead to loss of protective social connections

 Sexual and gender minority (SGM) young adults had higher levels of depression, PTSD symptoms and COVID-19-related worries and grief than non-SGM, even after controlling for family support, lifetime discrimination, and pre-existing mental health diagnoses

Clinical Update 12/20: Management of Uncomplicated Gonorrhea

- Ceftriaxone monotherapy
 - A single 500 mg IM dose of ceftriaxone is now recommended for uncomplicated gonorrhea. Dose is 1 gram for persons weighing ≥150 kg (300 lbs).
 - Azithromycin is no longer recommended as adjunct due to *N. gonorrhoeαe* resistance
- Chlamydia coinfection
 - Oral doxycycline (100 mg BID x 7 days) should be administered when chlamydial infection is confirmed or has not been excluded
- Expedited Partner Therapy for Gonorrhea
 - Partners may be treated with a single 800 mg oral dose of cefixime (Add Doxycycline 100 mg BID x 7 days if chlamydia has not been excluded).
- Test of cure recommended for oropharyngeal gonorrhea

Clinical Preview 12/20: CDC STI Guidelines 2021

(anticipated release Summer 2021)

- Chlamydia
 - Updated gonorrhea guidelines recommend doxycycline over azithromycin for empiric cotreatment of chlamydia
 - For chlamydia only, doxycycline will also be preferred, due to superior coverage for rectal CT
- Be on the lookout for changes in management for:
 - Trichomonas vaginalis
 - Pelvic Inflammatory Disease
 - Mycoplasma genitalium

Clinical Update: HIV Pre-Exposure Prophylaxis (PrEP)


• HIV PrEP

- Emtricitabine/tenofovir (Truvada)- any persons >35kgs
- Descovy- not for cisgendered females having vaginal intercourse
- Link patients to PrEP services
 - MSM with STI's
 - Anyone with multiple STI's per year
 - Discordant partners of HIV+ individuals
 - Anyone interested in PrEP can be referred for education/counseling




