### What is Code Correct & KnowledgeSource Pro?

**CodeCorrect** is a service that performs a real-time review of claims and checks them against the published Medicare edits, thereby minimizing the chances of a claim being rejected.

This is a third-party product that is owned by FinThrive and integrated into eClinicalWorks.

KnowledgeSource Pro

**Integrated CodeCheck:** This service supports Medicare Part B claim scrubbing for NCCI (National Correct Coding Initiatives), NDC, LCD ABN eligibility, and other published Medicare edits.

This service provides a real-time check of claims for appropriate modifiers, CCI edits, code validity, ABN eligibility requirements, and medical necessity verification, among other significant elements

## **Code Correct Configurations**

This will be configured by eCW with the practice credentials received from the vendor

### Code Correct Edits

### Code Correct Insurances





Symptoms, signs and abnormal clinical and laboratory findings, not Chapter Details elsewhere classified (R00-R99) **Chapter Notes to Remember!** Excludes 2 abnormal findings on antenatal screening of mother (028,-) certain conditions originating in the perinatal period (P04-P96) signs and symptoms classified in the body system chapters. signs and symptoms of breast (N63, N64.5) This chapter includes symptoms, signs, abnormal results of clinical or other investigative Notes procedures, and ill-defined conditions regarding which no diagnosis classifiable elsewhere is recorded. Signs and symptoms that point rather definitely to a given diagnosis have been assigned to a category in other chapters of the classification. In general, categories in this chapter include the less well-defined conditions and symptoms that, without the necessary study of the case to establish a final diagnosis, point perhaps equally to two or more diseases or to two or more systems. of the body. Practically all categories in the chapter could be designated 'not otherwise specified', 'unknown etiology' or 'transient'. The Alphabetical Index should be consulted to determine which symptoms and signs are to be allocated here and which to other chapters. The residual subcategories, numbered .8, are generally provided for other relevant symptoms that cannot be allocated elsewhere in the classification. The conditions and signs or symptoms included in categories R00-R94 consist of: (a) cases for which no more specific diagnosis can be made even after all the facts bearing on the case have been investigated; (b) signs or symptoms existing at the time of initial encounter that proved to be transient and whose causes could not be determined: (c) provisional diagnosis in a patient who failed to return for further investigation or care: (d) cases referred elsewhere for investigation or treatment before the diagnosis was made: (e) cases in which a more precise diagnosis was not available for any other reason; (f) certain symptoms, for which supplementary information is provided, that represent important problems in medical care in their own right.
